# GET TO KNOW YOUR ELECTED REPRESENTATIVES

This 2025 LEGISLATIVE DIRECTORY is produced by the Colorado Rural Electric Association, the trade association for Colorado's electric co-ops.

This directory is designed to help you connect with the legislative process here in Colorado and in Washington, D.C. Use this directory to contact your representatives. Let them know what is important to you, what you want to happen in this year's legislative and congressional sessions, and how their actions affect you, your business, and your community.



**Writing an email, letter, or calling your legislator is the most effective way to communicate your support, concern, or interest in an issue before the General Assembly. As you begin this process, consider the following tips:**

- Take a little extra time to educate yourself on the topic you wish to address.
- When you write, identify yourself and your status as a constituent.
- Be specific. Use bill numbers and state your position plainly.
- Use examples that illustrate how the issue affects your local area.
- Be respectful. Use appropriate greetings such as "Dear Senator Smith" or "Dear Representative Jones."
- Provide a way for your legislator to respond by including your mailing address, email address, or phone number.
- Always be respectful. Even if you disagree with a lawmaker's position, end your correspondence by thanking them for their service.
